

Truly Called to Serve

This family is an example that every Christian family should follow. Their life is built around the Catholic Faith. They truly enjoy giving their services to our Lord; never complaining and always with welcoming smile. Both are always in the back of the Church each Mass that they attend; welcoming Parish Members and Visitors always assuring their needs are met to include providing assistance as needed

They are continuously involved in many community and parish function and events. Even when they are involved individually in an activity, the other one is always in the background giving their support.

She is involved in the local Hospice Program Services. Always assuring every member of the Terminally III Patient is aware of the phases that will occur. This is a great relief to all concerned. He is always available as a spiritual adviser as well as helping her provide the necessities to the family when needed.

Both are involved in a Non-denomination Church Group which provides religious services to the Leakeville MS Prison population. This involves providing Sunday Services and Spiritual advice to the inmates. Many times she helps the women of the group prepare meals and provide spiritual advice to the family members of the inmates and staff

He is Head Chef and organizer for our Gumbo Take Out which supports and provides funds for the Priest Education Fund; this includes purchasing materials; preparing; cooking; packaging and distributing the gumbo. She is in the background helping him secure the supplies and helping him prepare the ingredients. She was always providing humor and assistance when needed. 480 quarts were prepared which provided \$2400 for our Dioceses Priest Education Fund

During the week and often on Friday Mornings, you can see them at St. Vincent De Paul Clothing Store, receiving; sorting according clothes to gender, age, and type; and placing them in appropriate sections and assisting the needy in their selections to assure they receive the appropriate items for each member of their families. They always inquire about the welfare of these needy families to insure they are receiving the necessities of life. And when appropriate; they provide information of agencies where they receive the assistance they need

They both are involved in prayer groups which they co-chair the weekly meetings. Her group often conducts the Rosary service for deceased Parish Members. They ensure that the family members of the deceased have the necessities (food, transportation, accommodations, etc). Both provide assistance to each other's group as necessary. They are very involved in Pro-Life. He schedules Knights during the Months of October and May to say rosaries before every weekend Mass. They both encourage Parish members and other Non- denomination Church members to attend the annual Life-Chain

They are both involve in providing religious training to RCIA, Confirmation; and Baptism candidates; Lecturers, Ushers; CYO members; CCD classes; etc. and always providing religious guidance, assistance and advice when needed.

This family is truly called to serve. Besides of all the things they do that are listed above. He serves as a Deacon for two different Parishes, thus he conducts many of the services our Priest does; only he does not get paid. She readily accepts her responsibilities of being a Deacon's wife and shares the joy of providing religious; social and physical assistance to the Parish Members; Non-Denomination Church Members; the Needy; Etc. One could say that he is a Deacon; therefore that is what they are supposed to do. I say; it is every Christian Catholic Family's responsibility to follow their example
