



The Knights of Columbus Councils of Mississippi have established a program to pray the rosary to end abortion. We will pray at the abortion clinic on State and Fondren Streets in Jackson on the <u>third</u> Saturday of every month from 10:00 to 11:00 AM. The councils are asked to come as a council and invite all parishioners to come and pray with them. December 20 and January 17 are the next dates. Please bring your council banner.

January 22 is the anniversary of the Roe vs. Wade decision of the U.S. Supreme Court that ruled abortion to be legal up to the moment of birth of the baby. To coincide with this, the Knights of Columbus will participate in activities on Saturday, January 17 from 9:30 to 11:00 AM (on this day only) at the abortion clinic on State and Fondren Streets. The 4th Degree Honor Guard and Color Corp will be present. A multi-denominational singing group of young persons will lead in song. State Senator Richard White of Senate District 29 will speak on pro-life legislation. We will pray with the various denominations present.
