### COATS FOR KIDS BENEFITS SACRED HEART SOUTHERN MISSIONS

Sacred Heart Southern Missions provided 127 winter coats to children in the Walls charity's service area thanks to the generosity of parishioners in Southaven, Hernando, Senatobia and Robinsonville and Hernando DeSoto Council 7120 of the Knights of Columbus.

The Council took up Supreme's Coats for Kids cause in November with a \$500 commitment then posted Knights at Masses over Thanksgiving weekend at Southaven Christ the King, Hernando Holy Spirit, Senatobia St. Gregory and Robinsonville Good Shepherd for donations from parishioners wanting to assist. They responded with an additional \$2,500.

The Council purchased the coats locally as ages, sizes and the sex of children to be outfitted were provided by SHSM.

Council leaders noted that support from the pastoral team, staff at the Parishes, Knights and others who volunteered to collect donations; the religious and staff at Sacred Heart Southern Missions; and the depart-
