# 7 Organizations Receive \$11,000 Collected in PID Drive

The Knights of Columbus Foundation of Mississippi, meeting at St. Francis Parish in Madison, distributed \$11,000 collected during the 2008 fund drive for People with Intellectual Disabilities (Tootsie Roll drive) to seven organizations throughout the state.

The Foundation is the 501(c)3 organization that distributes funds raised by Mississippi Councils in the annual fund raiser, with 75 percent of the funds returned for local distribution and 25 percent distributed on a statewide basis.

Mississippi Special Olympics received \$5,000, with \$1,000 each going to Ellisville State School, Boswell Retardation Center, North Mississippi Regional Center, South Mississippi Regional Center, Midwest Industries and the Brain Injury Association of Mississippi.

PID Chairman and Foundation Executive Director Jim Farris of Southaven Hernando DeSoto Council 7120 reports that several Councils submitted fund drive checks, noting that additional funds will follow. Several others have not submitted disbursement forms that direct the Foundation in the distribution of funds to the local program or facility.

"We are holding funds for Councils that have indicated more money will be submitted or that have not submitted a disbursement form," Farris said. "The Foundation's fiscal year ends April 30, and we would like to have all funds distributed by that date."

Councils that have submitted PID funds but have not received a return check for 75 percent of those funds should contact Br. Farris and submit a disbursement form.

Farris also noted that a few checks returned to Councils for distribution have not cleared the bank. He requests that Councils holding a check for some reason expedite its processing to meet the fiscal year-end date.

"Finally, thanks to all Councils for what they do for these 'special persons'," Farris said.

He also announced the 2009 PID drive dates are May 17-23.

# Laurel Council Honors 'Pat' Myers' on 70 Years as a Knight

A large delegation of past and present state officers, friends, colleagues and family turned John P. 'Pat' Myers' 88<sup>th</sup> birthday and celebration of 70 years as a Knight into a night to remember with a Mass and dinner hosted by Laurel Council 2180 and Arthur F. Axton Assembly 563.

The longest living member of the Past State Deputies Association in Mississippi was initiated into the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Degrees of the Knights of Columbus on Jan. 11, 1939, at Bay St. Louis and into the 4<sup>th</sup> Degree on July 21, 1946, at Jackson. He is a lifelong member of Immaculate Conception Parish in Laurel, where he has served as an altar boy, lector, Eucharistic Minister and member of the Parish Council and Finance Committee for many years. He also served as president of the Immaculate Conception School Board.

On the state level, Pat was elected State Secretary in 1948, and in 1950 was elected to a two-year term as the youngest State Deputy ever in Mississippi. He also was elected to a term as State Treasurer; received the Knight of the Year Award from the State Council, served as chairman of the Audit Committee for several years, edited The Magnolia Knight and served as Executive Secretary for six years. He has worked on the Tootsie Roll fund-raising drive (now the People with Intellectual Disabilities drive) since it was adopted in Mississippi.

At the 4<sup>th</sup> Degree level, Pat served seven years as State Master; received the Charles C. Jaubert Memorial Award from the Msgr. Cramer Assembly in Lake Charles, LA, in 1991; was awarded the Distinguished Service Membership Award as Master with star in 1988-90; and was awarded the Knight of the Year award in 1985-86 by the Bienville Province of the 4<sup>th</sup> Degree. He also received the Fred L. Westbrook, Sr., Knight of the Year Award in 1988.

Pat has served on the Diocese of Biloxi Finance Council since its in-

### **TOURNAMENT RULES**

- 1. American Bowling rules and the following shall govern this tournament.
- 2. Open to all members of the Knights of Columbus, Ladies Auxiliary and Columbian Squires in good standing.
- 3. There will be one cash prize awarded for each five entries as prize funds allow, including all events. Suitable trophies will be awarded to the winners in each event.
- 4. Individual handicaps will be computed on the basis of 90 percent of the differences between each average and 200.
- 5. League bowlers use highest sanctioned average for 21 games or more for 2005-06 season. Where no average last season, use highest average for 21 games or more as of Jan. 1, 2007. Where current average of 21 games or more is 10 pins higher than last season's average, then the current average must be used. No summer league averages allowed.
- 6. It is the responsibility of each entrant to provide the tournament chairman with his correct average whether submitted by the bowler, his team captain or others. Failure to do so shall disqualify the score if the average submitted is lower than the actual average thereby resulting in more handicap. Prize-list winnings will be based on the average submitted if higher. All bowlers participating in the tournament who may be subject to re-rating in accordance with the ABC rules 363-b and 363-c apply and ABC rule 363-d is waived for this tournament.
- 7. Substitutions in each event are allowed, provided the tournament chairman is notified at least 30 minutes prior to the scheduled time to bowl and the average of the substitute is certified.
- 8. A bowler may, if necessary, bowl in the team event twice, and the team may bowl later after the first round with one bowler bowling twice. The first team event score shall count toward all events score. Bowl one time only in singles and doubles. An entry in singles must include doubles entry and vice versa. Entry forms must be complete showing all data requested.
- 9. Telescores will be official records of scores, and any errors in scoring must be reported before transferring to recap sheet.
